


# Stephen King (1818-1852)

Madison & Franklin Counties, Ohio—Carroll County Missouri—Polk County/Benton County, Oregon Country Born July 13, 1818 Madison County, Ohio
Which was formed in 1810.
The country was recovering from The War of
1812, which Stephen's father, Nahum, served
from Delaware County, Ohio. Madison
County was established in 1810 is near
present-day London, Ohio. Franklin County
was established in 1803 near present day
Columbus, which became the state capital in
1812. These counties were primarily
agricultural. Canaan township and Darby
Township are in the NE part of Madison
County.

He is the seventh child of Nahum and Sarepta Norton King and their second son. The family moved here from Enfield, Hartford, Connecticut where they lived for a short time in 1810. They remained in Ohio almost 30 years until after 1840 (Franklin County, Ohio Census) when they moved to Carroll County, Missouri.










CARROLL COUNTY COURT HOUSE, CARROLLTON, MO.

She was born March 26, 1822, Enfield,
Hampshire County, Massachusetts.
Her parents, John Allen (1776-1842)
and Anna Bangs Allen (1785-1860)
had moved to Canaan, Madison
County, Ohio in 1841 and Anna Maria
left with Stephen King and his family
four years later for Oregon Country.

Enfield, MA was flooded in 1938 with the creation of Quabbin Reservoir, to provide more drinking water for Boston, MA



#### ANNA MARIE (MARIA) ALLEN KING MARCH 26, 1822-SEPTEMBER 30, 1905


#### IN THE GRAVE.

Death and Burial of Mrs. Sol King—One More Pioneer Gone.

Annie Maria, the wife of Sol King, died at the family home near Corvallis last Saturday evening after an extended illness. She was one of the earliest settlers of Benton, having settled in Kings Valley in the spring of 1846, nearly sixty years ago. She was born in Ohio in April 1822, and was aged 83 years, six months and four days. She resided in Ohio until 1841 when she moved to Missouri, and after four years there, she left by ox team for Oregon in the spring of 1845. The train arrived at Lynton, on the Willamette on the last day of November, 1845. The details of the long journey are recounted in a letter written April 1st. 1846, from Kings Valley, which letter is still in existence in the East and which appeared in the TIMES June 21st last.


The funeral occurred from the late home Monday forenoon, and the service was conducted by Rev. Bush. The interment was in Odd Fellows cemetery. Surviving members of the family are, Mrs. W. B. Kiger, Scott King, Eli King, Abe King, William King, and the husband.






Town Hall, 1938. Enfield, MA









In the spring of 1845 Stephen and Anna Maria King traveled to Oregon County with Stephen's extended family. They spent the first winter on the Tualitin plains, near Gales Creek and present-day Forest Grove. In the spring of 1846 they traveled by Hudson's Bay Pack Trail into the Kings Valley/Wren area of Polk County.

Benton County was created from Polk County Dec. 23, 1847. Many pioneer residents still traveled to Dallas, Polk County, Oregon to do business as it was an easier road than to Corvallis, Cardwell Hill Rd built before 1855.

### Letter from Luckiamute Valley, OR April 1, 1846 signed Stephen and Mariah King

- \* "...Stephen was taken with the fever at Fort Boise. He has not been well since we left Ohio, but was now taken worse. He was sick for three months. We did not expect him to live for a long time, but he is now well and hearty, getting fatter every day..."
- Possible illnesses were consumption or tuberculosis and a lingering sickness called "mountain fever" which could be malaria or typhoid fever. Anna believed it to be consumption.
- \* Stephen would live 6 more years. He died Nov. 28, 1852. Oregon was not yet a state when he died. It was known as Oregon Territory. It became a state in 1859.
- In those six years let us see what Stephen accomplished.




9, 1854 Rowland Chambers was also appointed in that role. It sold in a Sheriff's Sale on mortgage foreclosure April 19, 1941.

- >Nahum, King and Solomon King, father and brother. Sol King stayed in the area until 1872 when he sold most of his land and holdings and moved to Corvallis. Much of it was sold to James and Sarah Robinson for \$10,000.
- >George P. Wrenn had a DLC just North of original village of Wren. The town of Wren has his name.
- >Jonathan Mason, Barbara Mason, Peter Mason
- >George W Mason's DLC eventually was purchased by 23-year-old Charles Allen King in 1869, \$1800.00
- >Byron P Cardwell, had a cabin on his DLC when Cardwell Hill Road was built in 1855.

It was the shortest route to Corvallis.

- >Oscar F Clark, Came to Oregon in 1847 and lived with the Kings for a time. Friends before coming to Oregon. Sol King stated he saw Osca & Stephen King ride off and return together from Cayuse Indian Wars, 1848.
- >Perman Henderson, had land where original village of Wren stood
- >William Pearson
- >John Phillips. Sol King purchased this DLC and sold it to Robinsons.
- >Isaac Miller
- >James Edlemam. Sol King purchased this DLC in 1870 and sold it to the Robinsons.

- >Amos Blakesley
- >Isaac Spawr, had a sawmill near present-day Harris and sold it to Sol King about 1860. Sol sold it to Jonathan and Mary Pitmannin 1874 for \$2,000.


Stephen served in the Cayuse Indian War for 3 months in 1848. Stephen's younger brother, Sol, watched Stephen and Oscar F Clark, a family friend, ride away and return together. They served with the First Regiment with The Oregon Rifleman. On Jan 9, 1848 Colonel Cornelius Gilliam from Polk County, who lived along the Luckiamute river, started out for The Dalles with a contingent of 220 men. Years later, Mary Anne Allen Oscar, widow of Oscar F Clark, applied for a military war pension and Sol King spoke at the deposition.

The grist mill was finished in 1853.

Stephen died November 1852.

My father, Charles KING, was born in 1848. He was the son of Stephen KING and the stepsen of Sol KING. Stephen KING died not long after coming to Oregon, and later his brother married his widow. Although that part of the Luckianute River valley in Benton County is called Kings Valley, only one of the KING Brothers, Isaac, actually

settled there. Amos KING settled on the site of Portland and Mahum and Sol KING settled on Marys River near Wren.

Sol KING soon sold or transferred his farm and went to Corvallis where he served as sheriff for ten years

following 1876.

## What Became of Anna María and Charles after Stephen King's death.

- \* Stephen King's younger brother, Solomon King, married Anna Maria November 23, 1853. Sol was age 20. Anna age 31.
- \* About 1856 Sol, Anna Maria, and Charles lived on his father's farm near Wren. Sol purchased other land in that area, farmed, and ran a sawmill until 1872-74 when he sold out in the Wren area and moved to Corvallis to set up a livery business.
- \* Sol and Anna Maria remained there until their deaths, raising 6 children to adulthood.
- \* Charles King remained in the Wren/Harris area, named after George H Harris, who settled there 1890. It was renamed Elam (which did not stick) when the PO opened in 1893. Charles logged his father's land as well as his own land near Harris. He married twice to Martha Susan Robinette, and had 3 children. After divorcing Susan, he married Margaret E Barnes and had a daughter, Ethel Jane King Morgan (1899-1977).

Charles Allen King (1848-1915)
married Martha Susan Robnette (1852-1919)
Dec. 12, 1869. After 25 years this marriage ended in divorce (about 1892).
Susan moved out and Charles filed on grounds of desertion. Her 2nd husband was Thomas C Casey, married about 1900.

Three Children were born to the marriage of Charles & Susan:

- > Charles Edward King (1871–1949) who married Minnie M Harrison.
- > Anna Maria King (1873–1938) never married. Wren Cemetery.
- >Adella King (1875–1954) married Samuel Creed Turner about 1875.












The settlers soon learned that the land near Wren and Harris grew trees better than any other crop. Charles King logged Stephen's land as well as his own. Later names like Starker Brothers and Rex Clemens were huge timber land owners in the area. Just last year Stephen's land was logged again.

Hi, We are trying to locate the approximate location of the Stephen King grave. Stephen is buried on his DLC (Similar to his brother Isaac King).

The grave is unmarked. It appears that Starker Forest may be the present owner and if so, we can get permission to furnish a monument. Could you get us some information similar to what you are furnishing for Amos King?

Bill Dixon and I have interviewed some old timers in the Harris area. Harris is not far from Wren and not far from the Nahum King DLC. It appears the grave was fairly well marked until the land was logged and the rock markers were dozed. We can't even find out where that
